- THAT the Official Liquidator’s remuneration of \$31,000.00 and disbursements of \$2,103.29 for the period from August 3, 2018 to January 31, 2024 are approved.

Any creditor of the Company wishing to attend the meeting must notify the OL of such intention by email to jz@cjacayman.com by no later than 5 pm Cayman Islands time on Thursday, April 25, 2024. Corporate creditors wishing to attend must complete and submit the attached proxy form. Upon receipt of the required documentation, teleconference dial in details for the meeting will be provided by return email.

Only those creditors who have submitted a proof of debt (with adequate supporting documentation of their claim) and whose claims have been admitted for voting purposes by the OL will be permitted to vote at the meeting.
